# TO CONFIRM MINUTES OF PROCEEDINGS OF PREVIOUS MEETINGS AND REVIEW THE PROGRESS.

**O1**. **RESOLUTION** - Confirmed minutes of the last meetings and approved the action taken thereon with the following further modifications and suggestions:-

# ITEM NO.40 DATED 03.06.2015

Shri Suresh Kumar, Elected Member raised the issue non re-erection of public urinal near Police Station in Sadar Bazar which was approved by the Board.

Smt. Puneet Kaur brought to the notice of the President Cantt Board that there is mandir near the proposed site. Chief Executive Officer pointed out that the said mandir is an encroachment on the road side land.

Shri Rajinder Sharma, Elected Member suggested that public urinal near Sports Complex be made in covered shape for public use.

The CEO brought to the notice of the Board that public utilities should be at place where people are frequenting the area for its optimum utilisation and the mandir constructed or public land should not come in the way of public utilities.

The President Cantonment Board informed that he will inspect the site and the Board will take decision accordingly.

## ITEM NO.01 DATED 14.08.2015

The Elected Members requested the CEO to intimate the status of proposal submitted by the Board for seeking sanction for licencing the sites for installation of communication towers (COW) to the GOC-in-C through the Directorate. The Directorate have recommended the proposal to the Directorate General for obtaining Govt. sanction and the same is pending sanction with the Ministry of Defence.

Hence the same has been developed and converted into a park for use and benefit of the residents of Cantonment. The Nav Yuvak Valmiki Sabha (Regd) Jalandhar Cantt vide their request dated 05.01.2015 has requested for naming this park as Bharat Rattan Dr. B.R. Ambedkar Park. The Sabha has also come forward to look after the park with the assistance of Cantt Board. The request of the Sabha is recommended by all the elected members.

The Board may consider naming the park as "Bharat Rattan Dr. B.R. Ambedkar Park" as there is no other Cantt Board property named or dedicated to the memory of the father of constitution of India.

The highest bid of Rs.1,56,000/- per month is offered by Sh. Vishal Gupta S/o Balwinder Gupta R/o-NE81, Purian Mohalla, Near Mai Hiran Gate, Jalandhar City for occupation of the said property as per the terms and condition approved by the Board is reasonable and in the financial interest of the Board. RESOLUTION- Shri Suresh Kumar pointed out that a complaint has been received in the office of the Cantt Board objecting to the use of this particular place for the purpose of marriage palace it being in proximity to school and hospital. The CEO informed that there is such a complaint from one Shri Om Parkash Sharma. CEO further suggested that the site is being used for the same purpose for the last so many years hence the Board should reject such complaints as the complainant himself has earlier participated in tender proceedings and in this tender also purchased tender documents. Hence the complaint appears to be have made out of vested interest. Hence the Board resolved to reject the complaint and go ahead for disposing the site for the purpose on license.

The Board considered the issue in detail and unanimously resolved to approve the highest bid of Rs.1,56,000/- offered by M/S Vishal Gupta S/O Sh. Balwinder Gupta subject to the approval of the GOC-in-C as required u/s 267(2) of the Cantonments Act 2006.

Shri Suresh Kumar asked the status of handing/taking of the possession and payment of license fee by the ex-lessee. CEO informed the Board that the ex-lessee and the highest bidder have given in writing that they had sold/purchased the temporary structures, and the ex-lessee has deposited dues with a request to adjust the security deposit with the Board. Sh. Suresh Kumar suggested that the security deposit be released/adjusted after proper recovery of all the dues after vacation of the site and damage as per licence agreement be charged.

### ITEM NO.21

LICENSE OF FISH MARKET AND CHICKEN SHOPS RUNNING UNDER THE MANAGEMENT OF CANTONMENT BAORD, JALANDHAR CANTT FOR SALE OF FROZEN CHICKEN/FISH PRODUCTS WITHOUT SLAUGHTERING.

Reference Spl. CBR No.01 dated 24.09.2015.

In continuation to instructions issued by the Punjab Pollution control Board vide letter dated 17.09.2015, the Cantonment Board, Jalandhar vide referred CBR decided to terminate the existing licenses of the running chicken Shops i.e. Nos.2 & 4, opposite mutton market, and fish stalls No.1&2 in mutton market, Jalandhar Cantt by issuing one month notice as per terms of the license agreements executed with the licensees due to non-availability of Effluent Treatment Plant. In this regards letters

dated 01.10.2015 were issued to the existing licensees of the chicken shops no.2 & 4, opposite mutton market and fish stalls no.1&2, mutton market, Jalandhar Cantt intimating termination of the licence after one month and requiring them to hand over vacant possession of the cantt fund properties within one month from the date of receipt of the letters.

The Board vide referred resolution further resolved that the licenses be issued for sale of frozen fish, chicken and mutton stall imported from slaughter house authorized by the competent authority.

It is informed to the Board that, the existing licensees of the chicken shop no.4 and of fish stalls No. 1& 2 have submitted vide their requests both dated 09.10.2015 that no slaughtering will be made in the market and requested that they may be allowed to continue the existing license agreements executed by them for sale of frozen fish and chicken in the market.

The requests of the licences are put up for consideration of the Board.

21. RESOLUTION- The Board consider the issue in detail. Sh. Suresh Kumar pointed out that the Board should not allow the applicants changing its own resolution within three months in violation of business regulations. CEO informed that the Board is not amending its own resolution but rather the applicants have made their submission that they are ready to comply with the requisition of the said resolution of the Board regarding sale of frozen chicken, fish and mutton. Shri Rajinder Sharma, Elected Member suggested that the shops should be renovated and made air-conditioned and be given on license for sale of frozen fish, chicken and mutton for generation of local revenue.

Shri Sanjeev Trehan, Elected Member suggested that the Board should accept the request for allowing them for sale of frozen items only.

The Board considered the issue in detail and unanimously resolved that in compliance of spirit of law the Board should allow the sale of frozen items like chicken, fish and mutton (goat meat) under the existence licenses.

The Board further resolved that periodic/weekly inspection done by the AHO and daily checking done by the Sanitary Inspector and assure that there is no slaughtering of animals and sale of unauthorised chicken, fish and mutton.

The Board further resolved that ETP be planned and market reconstructed and renovated for providing better quality services.

# **ITEM NO.22**

TO RECOVER THE ARREARS OF LICENSE FEE, SERVICE TAX AND ELECTRICITY BILL OF THE CANTT FUND PROPERTY KNOWN AS FISH STALLS NO.1&2, MUTTON MARKET, JALANDHAR CANTT.

Reference CBR No.14 dated 30.07.2015.

To consider the report of the tax section, regarding irregularity due to non payment of monthly license fee, Service tax and arrears of electricity bill by Sh.Jugal Kishor, licensee of Fish Stalls No.1&2, in mutton market, Jalnadhar Cantt, the Board vide reference CBR resolved that one last opportunity be given to the licensee to deposit the arrears of license fee, Service tax and arrears of electricity bill.

The Cantt fund property known as Fish stalls no.1 & 2, Mutton market, Jalandhar Cantt was licensed out to Sh. Jugal Kishor S/o Jagan Nath, resident of House No.17/5, Mohalla No.4, Jalandhar Cantt for a period of three years i.e. from 01.04.2013 to 31.03.2016 at the license fee of Rs.7,100/- per month. The following irregularities had been noticed in the property as per report dated 24-07-2015 submitted by the Tax Supdtt in the Board dated 30.07.2015:-

- (1) <u>DISHONOR CHEQUES OF MONTHLY LICENSE FEE</u>:- Due to non clearance of the monthly license fee for the month of <u>December</u>, 2014, legal notice was issued u/s 138 of the Negotiable Instrument Act on 26.12.2014, but he failed to deposit the monthly license fee with legal charges and the case was referred to the court for recovery of the cheque amount. Similarly legal notice was issued to the licensee due to non clearance of the monthly license fee for the month of <u>July</u>, 2015, but he still failed to deposit the monthly license fee with legal charges. (The licensee deposited the monthly license fee for the month of <u>July</u>, 2015, but till date failed to settle the matter of cheque dishonored payment of monthly license fee for the month of <u>December</u>, 2014)
- (2) <u>ARREARS OF SERVICE TAX</u>:- A sum of Rs.10,370/-(Rs.9,890/- as service tax for the period of 01.09.2014 to 31.07.2015 and Rs.480/- as interest on delayed payment of service tax), is due against the licensee, but he failed to deposit the same till date. (arrears of the service tax paid by the licensee)
- (3). ARREARS OF ELECTRICITY BILL:- A bill amounting to Rs.9,921/- (Rupees nine thousand nine hundred twenty one only) is due as usage of electricity bill of the electric meter no.J65CA180017Y for the period 21.08.2014 to 19.10.2014, which was installed in the name of E.O., Cantt Board, Jalandhar Cantt in meat market and was used jointly by the licensees of mutton & fish stalls. During that period only the licensee of Fish Stalls No.1&2, in Mutton market was using that connection as the part of mutton stalls was under repair so it was not licensed out. (A report was taken from Cantt overseer on the subject matter. As per report of the C.O., Cantt Board a sum of Rs.1,700/- can be recovered from the contractor. Thus balance amount i.e. Rs.8,221/- be recovered from Sh.Jugal Kishor)
- **22**. **RESOLUTION** The Board discussed the issue in detail and resolved that the licensee Sh. Jugal Kishor of Fish Stalls No. 1 & 2 in Mutton Market Jalandhar Cantt has to pay the arrears of license fee, service tax and electricity bill of the Cantt Fund Property as mentioned in the agenda side.

### ITEM NO.23

# TO REVIEW THE PAYMENT OF OVERTIME WAGES OF CANTT BOARD EMPLOYEES DUE TO FINANCIAL CRISIS.

Reference C.B.R. No.13 dated 15.05.2002.

To consider the request dated 23.09.2015 of Sanitary Supdtt., and Octroi Supdtt., Cantonment Board, Jalandhar Cantt regarding review the payment of overtime wages to the Cantt Board employees for performing essential duties on 14 Gazettered holidays.

The Board is informed that the Board suspended payment of overtime to the officials of Sanitation deptt and Octroi deptt vide referred resolution keeping in view of shortage of funds.

Both the superintendents have requested to review the case and release the payment of overtime wages.

In this connection all the relevant papers are placed on the table.

**23**. **RESOLUTION**- The Board considered and approved the payment of overtime wages to Octroi Supdtt and Sanitary Supdtt on performing essential duties on 14 gazetted holidays from now onwards.

## <u>ITEM No. 24</u>

# TO CONSIDER EXECUTION PETITION TITLED AS SUBHASH AGGARWAL V/S CANTT BOARD JALANDHAR.

The Board is informed that Cantt Fund Property known as Shop No. 05, Mini Complex, Hardyal Road Jalandhar Cantt was leased out to Sh. Subhash Aggarwal @ Rs.5300/- per month and the possession of the shop was handed over to him w.e.f. 01.04.1995 without executing lease agreement. Later on the Cantt Board vide CBR No. 22 dated 30.08.1995 waived off the lease rent from April1995 to August 1995 of the shop in question on the ground that shop was never handed over to him although he (lessee) had already deposited Rs 50,000/- as development charges and Rs15900/- as three months security of lease rent and Rs.5300/- as one month advance rent total amounting to Rs 71,200/-.

In January 1998 recovery suit was filed by Sh. Subhash Aggarwal, leasee of Shop No. 05, Mini Complex , Hardyal Road Jalandhar Cantt for refund of Rs. 71,200/- with interest @ 18% w.e.f 10.04.1995 and another recovery suit by the Cantt Board Jalandhar for recovery of Rs.2,08,449/- as lease rent of the shop in question from the leasee.

In the above suit , the court of Sh. G.S. Dhillon, civil judge Jalandhar vide passed order dated 21.03.2005 decree the suit with cost against the Cantt Board Jalandhar and held entitled the plaintiff (Sh. Subhash Aggarwal) to recovery of Rs.71,200/- along with interest @ 18% per annum from 10.04.1995 till date of decree and @ 6 % per annum thereafter. The same was also upheld by the appellate court. The RSA filed before the Hon'ble Pb & Haryana High Court, Chandigarh is pending as no stay has been granted. The next date of hearing is fixed for 18.12.2015.

Now execution petition titled as Subhash Aggarwal v/s Cantonment Board is pending before the court of Sh. Amardeep Sing, civil judge, Jalandhar. On last date of hearing, the counsel of the applicant filed a list of property relates to the Cantonment Board. In this regards a legal opinion was solicited from CLA Sh. Mandeep Sigh, Sachdev who advised the Board to deposit the decretal amount as per the orders passed by the court of Civil Judge(Jr.Div) Jalandhar on 21.03.2005. The next date in the said execution petition is fixed for 13.10.2015.

In case of non payment, then interest would be accrued and the warrants of attachment can be issued by the court against the Cantonment Board Jalandhar. Hence, the decretal amount has been calculated upto 31.10.2015 in terms of the court order dated 21.03.2005 and works out to Rs.2,44,037/-(Two lac forty four thousand and thirty seven only) is required to be paid to the plaintiff Sh. Subhash Aggarwal in the court on the next date. The payment will be booked under budget head B(2)(b). Board may consider payment of the referred amount to avoid payment of interest and attachment of properties.

**24. RESOLUTION**- Considered and approved to pay Rs.2,44,037/- as decretal amount calculated up to 31.10.2015 in terms of order dated 21.03.2005 passed by Sh. GS Dhillon, Civil Judge, Jalandhar to Sh. Subhash Aggarwal in the court on the next date to avoid payment of interest and attachment of properties. The Board further resolved that prayer be made to the Ld. court that payment be released against security as Board's appeal against the orders is pending in the Hon'ble High Court.

## ITEM NO.25

# PAYMENT OF CONTRACTUAL AMOUNT TO M/S WHIZ KID, AMBALA CANTT IN COMPLIANCE TO ARBITRATORS AWARD IN THE ONGOING COURT CASE IN THE COURT OF ADJ JALANDHAR.

The Board is informed that the Cantt Board vide CBR No.02 dated 30.03.2011 awarded the contract to M/S Whiz Kid, Ambala Cantt for providing teaching/non teaching staff in Cantt Board Schools, Jalandhar Cantt @ 44.5% (including service tax, EPF, ESI) for period of three years i.e from 01.07.2011 to 30.06.2014. A dispute arose over the deposition of EPF, ESI and service tax to the concerned department.

Due to non-payment of EPF/ESI and objection raised by the Member Cantonment Board, the contract was terminated vide letter No.JCB/12/48/3403/C dated 30.03.2012 due to non providing the proper detail of service tax, EPF and ESI which had to be deposited by the contractor and his pending bills were stopped.

Mr. Narinder Dhamija M/S Whiz Kid, Ambala Cantt applied for arbitration to settle his dispute. The President Cantonment Board was appointed as an arbitrator in the case. The arbitrator given his award on 05.06.2014 and directed Cantonment Board to release the entire payment to the petitioner excluding the ESI amount within two months and directed petitioner to approach the office of the respondent Board within one month in person by way of writing to claim the outstanding amount excluding the ESI amount and the Board to make payment within 15 days thereafter. The Board calculated total amount payable to the contractor after deduction of ESI amount is Rs.786005/-. Copy of award was sent to contractor Narinder Dhamija vide letter No.JCB/12/48/639/C dated 06.06.2014 and also informed him telephonically.

But instead of claiming the awarded amount the party approached the court of District Judge filing case u/s 34 of Arbitration and Conciliation Act, 1996 and the case was dismissed as withdrawn.

The applicant again filed another case u/s 36 of Arbitration and Conciliation Act, 1996 which is pending in the court of Sh. RK Sharma, ADJ, Jalandhar claiming an amount of Rs.14,30,401/-. In the reply Board has admitted that the Board has to pay Rs.7,86,005/- as an outstanding amount payable to contractor as per the award of Arbitrator. Now the case is at final stage and Hon'ble Court can any time pass an order to pay the said amount to the contractor. The amount will be booked under budget head G(1)(b).

In this connection all relevant papers are placed on the table.

**25. RESOLUTION**- Considered and approved to pay admitted amount of Rs.7,86,005/- as an outstanding amount payable to the contractor M/S Whiz Kid, Ambala as per the award dated 05.06.2014 of Arbitrator under budget head G(1)(b).

### ITEM NO.26

# <u>CASE OF COMPOSITION OF UNAUTHORISED CONSTRUCTION IN PROPERTY NO.47, MOHALLA NO.28 FALLING UNDER CIVIL AREA IN CANTT BOARD JALANDHAR.</u>

The Board is informed that as per the General Land Register property bearing survey No. 283/2127 is described as Courtyard No. 47 at Mohalla No.28, admeasuring an area of 6570 Sft., classified as class B-3 land under the management of Cantonment Board, Jalandhar Cantt. Holder of occupancy rights as per the GLR records are described as to "Owners of Houses Nos. 47/1 to 47/7". Nature of holder rights are Old Grant. An un-authorised construction was noticed in the said property, which was reported by the field staff on 20.08.2014 and accordingly notice under section 248 of the Cantonments Act, 2006 was issued to the occupier on 20.08.2014 requiring him to demolish the unauthorised construction.

Instead of demolish the unauthorised construction on ground floor, the occupier of the above mentioned property carried out unauthorised construction on the first floor without any permission from the competent authority and accordingly by taking serious note the action was initiated under section 5-B of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971 issuing notice No. JCB/PP(E) Act/3347/C dated 01-01-2015 under section 5-B of PP(E) Act, 1971 requiring the said noticee to stop further unauthorised construction on the first floor and also the unauthorised construction was sealed under section 5-C of the PP (E) Act, 1971 vide No. JCB/PP (E) Act/3345/C dated 02-01-2015 by the Estate Officer, Jalandhar Cantt and the proceedings were finalised for demolition of unauthorized construction.

Further the occupier of the above mentioned property submitted application on dated 12-02-2015 for composition of unauthorised construction and submitted composition plan alongwith forms, abstract of cost and registered admission deed.

Further the occupier had again submitted request vide application dated 13-05-2015 before the Estate Officer that he was ready to comply with the requirement of notice dated 01.01.2015 regarding demolition of the said unauthorized construction and requested to de-seal the sealed unauthorized construction. Considering the request the property was de-sealed enabling the noticee to demolish the said unauthorized construction vide Estate Officer's order dated 15-05-2015. The occupier again instead of demolition of the unauthorized construction has again vide request dated 28.05.2015 requested for composition of unauthorised construction.

The matter regarding composition of unauthorised construction was put up before the Board for consideration and Board vide CBR No. 41 dated 03-06-2015 resolved that if the applicant undertake submitting an affidavit that he is ready to comply with the requirement of the Cantonments Act rules, bye-laws made there under and to pay composition fee as fixed by the competent authority then the unauthorised construction may not be demolished. Regarding this case it was resolved that the composition fee be worked out for consideration of the Board and regularisation of other violation if any till then the demolition may be pended.

The noticee was informed about the decision of the Board vide letter dated 18-06-2015 and required the occupier to submit the documents pertaining to the above mentioned property as early as possible for the consideration of this case and imposition of composition fee for the regularization of unauthorised construction in the above mentioned property and the occupier vide his application dated 23-06-2015 has submitted the documents pertaining to his property viz. copies of registered sale deed, copy of the tax mutation certificate and a notarized affidavit undertaking dated 26-06-2015 through

which occupier has undertaken that he is ready to comply with the requirements of the Cantonment Act, 2006, rules bye-laws made there under and he is ready to pay the composition fee as fixed by the competent authority.

Detailed office report is put up on the table for consideration of the Board alongwith file for consideration of the Board.

**26. RESOLUTION**- Considered the issue in detail. The PCB pointed out that the applicant has wilfully gone ahead for raising unauthorised construction despite of repeated notices issued under the provisions of the Cantonments Act requiring him to stop and demolish unauthorised construction. He further pointed out that action under the provision of PP Act was also initiated, the applicant made request for opening of seal for the purpose of demolition of the said unauthorised construction but further requested for composition so the Board should not compound the said unauthorised construction.

Shri Sanjeev Trehan suggested the PCB that the Board should consider the case for composition if it is as per the Cantt Act and byelaws as the Board has already compounded unauthorised construction in Bungalow No.26 with the approval of the GOC-in-C. He further suggested that the unauthorised construction in civil area be compounded as the applicant has submitted all the documents and undertaken to pay the composition fee and taxes.

The President proposed that as a matter of policy the Board should not accept the request for composition and further action be taken as per law for demolition of the unauthorised construction. The Board agreed to the suggestion of the PCB and resolved to reject the request for composition.

### ITEM NO.27

# CASE OF COMPOSITION OF UNAUTHORISED CONSTRUCTION IN PROPERTY NO.94(P), OUTSIDE MOHALLA NO.21, JRC FALLING UNDER CIVIL AREA IN CANTT BOARD JALANDHAR BY SH. SANDEEP KUMAR.

The Board is informed that as per GLR the property bearing survey No. 283/2533, classified as B-3 land admeasuring an area of 0.68 acres is described as Estate of Dr. Hamid Ullah Beg at Mohalla No. 21, Outside and is an expired lease property under the management of Cantonment Board, Jalandhar and the nature of the holder rights are Cantt Lease form C for 49 years with effect from 28-11-1922 and the lease was expired on dated 27-11-1971. The predecessor of interest of the present occupant as already applied for freehold of the said property and deposited 25% of the then value of the land.

The unauthorised construction activity on the ground floor of the above mentioned property without any permission of the competent authority was reported on 27-04-2015 and accordingly notice under section 248 of the Cantonments Act, 2006 was issued to the occupier on 10-07-2015 requiring the noticee to demolish the unauthorised construction on the ground floor.

Further unauthorised construction activity on the first floor was again reported on 07-08-2015 and accordingly notice under section 248 of the Cantonments Act, 2006 had been issued to the occupier on dated 07-08-2015 requiring the noticee to demolish the unauthorised construction on the

first floor. The occupier vide his application dated 06-08-2015 requested this office for composition of unauthorised construction.

Detailed office report is put up on the table for consideration of the Board alongwith file for consideration of the Board.

**27. RESOLUTION**- Considered the issue in detail. The Cantt Code lease has expired and predecessor in interest of the applicant applied for free hold, deposited 25% of the land value at the time of application but free hold has not been sanctioned. The Board resolved to reject the request for composition in view of policy decision taken by the Board vide CBR No.26 dated 17.10.2015. Further action be taken as per law for demolition of the unauthorised construction.

# **ITEM NO.28**

# CASE OF COMPOSITION OF UNAUTHORISED CONSTRUCTION IN PROPERTY NO.85 & 85/1, MOHALLA NO.27 FALLING UNDER CIVIL AREA IN CANTT BOARD JALANDHAR BY SH. VIJAY KUMAR.

- (i) The Board is informed that as per the General Land Register maintained by Cantt Board, the property bearing Survey No.283/2038 & 283/2036 is described as Shop No.85 & Shop No. 85/1 respectively at Mohalla No.27, Jalandhar Cantt admeasuring an area of 84 Sft & 304 Sft. respectively and the nature of holder rights are Old Grant classified as class B-3 land under the management of Cantonment Board, Jalandhar. Holder of occupancy rights as per the GLR records are in the name of Sh. Bhagat Ram, Hari Ram.
- (ii) The successor-in-interest submitting admission deed requested for repair of roof of the said property by request dated 17.11.2014. Considering the request as per land policy permission was accorded to repair the roof of the property vide letter No.JCB/Engg/27/M.No.27/69 dated 29.04.2015.
- (iii) The unauthorized construction activity was reported on dated 24-07-2015 in ground and first floor and accordingly notice under section 248 of the Cantonments Act, 2006 was issued to the occupier on dated 27-07-2015 requiring the noticee to demolish the unauthorised construction. As the said noticee also encroached over drain so action under section 5-A of the PP (E) Act, 1971 was also initiated against the occupier. The proceedings of the PP (E) Act are under process. The occupier of the said property vide his application dated 21.09.2015 has requested Cantonment Board for composition of unauthorised construction and has requested this office that he is willing to pay the requisite composition fee as fixed by the Board and requested to compound/regularize the unauthorised construction.

Detailed office report is put up on the table for consideration of the Board alongwith file for consideration of the Board.

**28. RESOLUTION**- Considered the issue in detail. The applicant requested for repair of the existing property but instead in violation of the land policy and the permission resorted to re-construction even encroaching govt. land hence resolved to reject the request and further action be taken as per law for demolition of unauthorised construction.

### ITEM NO.29

CASE OF COMPOSITION OF UNAUTHORISED CONSTRUCTION IN PROPERTY NO. 3, 3/1, 3/2, 3/3 & ¾(P), MOHALLA NO.01 FALLING UNDER CIVIL AREA IN CANTT BOARD JALANDHAR BY SH. SHARWAN AGGARWAL.

The Board is informed that as per the General Land Register maintained by Cantt Board property bearing survey No. 283/21 & 283/25 to 27 is described as House No. 3, 3/1, 3/2, 3/3 & 3/4 (P), classified as class B-3 land under the management of Cantonment Board, Jalandhar Cantt. Holder of occupancy rights as per the GLR records are described as to "Ambala Commercial Bank Ltd. Jullundur Cantt". Nature of holder rights are Old Grant.

The unauthorized construction was reported on 14-08-2014 on ground floor and accordingly notice under section 248 of Cantt Act, 2006 was issued on 14-08-2014 requiring the noticee to demolish the unauthorised construction. Further unauthorized construction activity was reported on dated 18-09-2014 in ground floor and accordingly the unauthorised construction was sealed under section 249 of the Cantonments, Act, 2006 on dated 19-09-2014. Despite the seal the occupier of the above mentioned property had further carried out unauthorised construction without any permission which was reported 13-01-2015 and accordingly notice under section 320 of the Cantonments Act, 2006 for demolition of unauthorised construction was issued to the occupier on dated 13-01-2015.

The Occupier of the above mentioned property vide his application dated 29-01-2015 requested the Cantonment Board to compound the unauthorised construction and requested to CEO to de-seal the property enabling him to demolish the unauthorized construction. Further as per section 249 (3) of Cantonments Act, 2006 the property was de-sealed vide office letter No. JCB/Engg/27/M.No.1/15/283/287/C, dated 14-05-2015 by the Chief Executive Officer enabling the applicant to demolish the unauthorized construction. Further the occupier of the above mentioned property vide his application dated 14.09.2015 requested this Board for composition of unauthorised construction and has requested the Board that he is ready to pay the composition fee as fixed by the competent authority and requested this office compound/regularized the unauthorised construction.

Detailed office report is put up on the table for consideration of the Board alongwith file for consideration of the Board.

**29. RESOLUTION**- Considered the issue in detail and noticed that the applicant instead of demolishing the unauthorised construction has requested for composition of unauthorised construction. In view of the policy decision taken by the Board vide CBR No.26 dated 17.1.2008 the Board resolved to reject the request for composition.

### ITEM NO.30

CASE OF COMPOSITION OF UNAUTHORISED CONSTRUCTION IN PROPERTY NO.8/1, MOHALLA NO.05 OUTSIDE FALLING UNDER CIVIL AREA IN CANTT BOARD JALANDHAR : REQUEST MADE BY SMT. SAPNA AGGARWAL AND SMT. RENUKA GUPTA

The Board is informed that as per GLR record property bearing survey no. 283/2515 described as House No. 08 at Mohalla No.05 outside Jalandhar Cantt. The occupancy rights stands in the name of Ch. Ali Bux. This property measuring an area of 0.25 Acres, classified as class B-3 land and is held a 'Cantt Code lease' for 49 years terms for residential purpose which expired on 27.11.1971. The present

occupier vide their application dated 18.01.2008 has applied for renewal of lease under Govt. instructions / policy which is under process.

The present occupier known as Mrs Sapna Aggarwal vide her application dated 03.11.2008 had applied for repair of roof of ground floor and permission for repair of roof of said property was given vide this office letter No. JCB/Engg/2391/C dated 14.11.2008. In violation of term of the permission for repair on ground floor, the occupier carried out unauthorised construction on first floor as well and constructed RCC columns & RCC slab in the form of hall on the first floor.

Therefore, Notices under section 239, 247 and 248 were issued to the occupiers / applicants on 08.01.2009 requiring the noticees to stop unauthorised construction and to demolish unauthorised constructions on ground floor and first floor considering that there was no sanction building plan. The noticee did not stop further unauthorised constructions hence, a notice under section 5-B of the PP(E) Act ,1971 requiring demolition of the unauthorised construction was issued by the Estate Officer to the occupier No.JCB/PP(E) Act/3114/C, dated 02.02.2009 and the unauthorised construction was also sealed under section 5-C of the PP E Act,1971 on 02.02.2009.

The Estate Officer, Jalandhar Cantt issued final orders dated 17.01.2014 under section 5-B of the PPE Act, 1971 directing demolition of the unauthorised construction. In compliance the order of the EO the occupier demolished the un-authorised construction of RCC slab on first floor in presence of Cantt Board officials. The Cantt Oversees and other field staff vide its report dated 27.01.2014 confirmed the proceedings.

It is pertinent to mention that file of sanctioned building plan of the said property was traced later on for providing of information under RTI Act asked by the occupier which revealed the fact that the old building was duly sanctioned in the year 1931.

Presently, the occupier has constructed Brick Masonry wall by putting entrance iron gates in ground floor within plinth area under intimation to this office without any permission by this office.

Therefore, notice under sub-section(1) of Section 239 of the Cantonments Act,2006 requiring stop the work , has been issued to the occupier vide this office letter No. JCB/Engg/27/M.No.5/26 / 1183 dated 24th Sept,2015 . In compliance to the ibid notice the noticee has stop the work and further in reply to the ibid notice the noticee vide her letter dated 29th Sept,2015 has requested to compound the said unauthorised construction and is ready to pay the composition fee as fixed by the competent authority.

Detailed office report is put up on the table for consideration of the Board alongwith file for consideration of the Board.

**30. RESOLUTION**- Considered the issue in detail. The Cantt Code lease has already expired and the occupier has requested for renewal of lease. In view of the policy decision taken by the Board vide CBR No.26 dated 17.10.2015 the Board resolved to reject the request for composition. Further action be taken as per law for demolition of the unauthorised construction.
