
In this connection all relevant papers are placed on the table.

**01. RESOLUTION** – The CEO explained the details of various estimates provided in the draft budget estimates for the year 2016-2017 (Revised) and 2017-2018 (Original). The receipt and expenditure provided in the said budget were discussed. After detailed deliberations unanimously resolved to approve the budget estimates, it was further resolved that GOC-in-C, HQ, Western Command be requested to sanction the said budget estimates as required under the provisions of the Cantonment Account Code 1924 and the Chief Executive Officer is authorized to incur the expenditure to the extent of sanctioned budget provision.

The Board also discuss the point regarding shifting of cattle dairies from cantonment area to Subhana village.
