NOTIFYING THE WARD(S) / SEAT(S) TO BE RESERVED FOR WOMEN IN THE FORTH COMING ELECTIONS- 2020 OF JALANDHAR CANTONMENT BOARD.

Reference PD DE WC Chandigarh letter No.10 /GEN/Election-2020 /Cantt/DE/WC dated 25.11.2019 w.r.t. Dte. General Letter No.76/38/Ord Elect/C/De/2019 dated 21.11.2019 and Result of Draw of Lots for reservation of Seats/ Wards to be reserved for women -2019.

To consider the instructions issued by the Dte. DE WC Chandigarh vide letter under reference and also approve the result of draw of lots by the PCB for seats / wards **(excluding ward No. VI (Six) reserved for Scheduled Caste in 2019 and Ward number 03 & 07 which had been just earlier reserved for women in 2013)** to be reserved for Women in the forthcoming JCB Election-2020 which will be carried out on 12.12.2019 at 1100 hrs (copy enclosed) in the presence of all Elected Members, general public of Jalandhar Cantonment and Media representatives of various News Papers who wish to witnesses the proceedings.

The Board is informed that in order to comply with the instructions referred above and consequent upon the result of draw of lots by the President Cantt Board for two seats / wards to be reserved for Women on dated 12.12.2019 at 1100 hrs in the office of Jalandhar Cantonment Board following due process in accordance with rule 06 & 07 of CER-2007, whereby two seats so determined by took the draw of lots, shall be reserved for WOMEN in the forthcoming election-2020 of Jalandhar Cantonment Board .

Further, the Board is also informed that seats reserved by draw of lots for women -2019 as mentioned above, shall be effective for complete five years or till the next ordinary election, whichever is later, irrespective of election to fill any casual vacancy as provided under rule 06(d) & 07 of CER-2007.

In view of the above it is recommended that the Board approve the result of draw of lots for reservation of seats for women -2019 in terms of the rule 06 & 07 of CER-2007 to enable this office to forward the proposal to the Dte. DE Western Command Chandigarh for onward submission to the Dte. General DE Delhi Cantt for notification of seats for Wards of Jalandhar Cantonment, to be reserved for Women by the Central Government for publication in the Official Gazette.

RESOLUTION: The Board considered the issue and unanimously resolved to approve the result of draw of lots carried out on 12.12.2019 at 1100hrs by the President Jalandhar Cantonment Board in terms of the rule 06 & 07 of CER-2007 whereby seats for Wards No. **I (One) and IV (Four)** have been reserved for WOMEN for forthcoming JCB Election-2020 and shall be effective for further complete five years or till the next ordinary election, whichever is later, irrespective of election to fill any casual vacancy as provided under rule 06(d) & 07 of CER-2007.

The Board also resolved to forward the proposal to the Dte. DE Western Command Chandigarh for onward submission to the Dte. General DE Delhi Cantt for notification of seats for Wards of Jalandhar Cantonment, to be reserved for Women by the Central Government for publication in the Official Gazette.
