NOTIFYING THE WARD(S) / SEAT(S) TO BE RESERVED FOR SCHEDULED CASTE OR SCHEDULED TRIBES FOR FORTHCOMING ELECTIONS- 2020 OF JALANDHAR CANTONMENT BOARD.

Reference Dte. General Letter No.76/38/Ord Elect/C/De/2019 dated 21.11.2019.

To consider the instructions issued by the Dte. General DE New Delhi vide letter under reference on the cited subject. The Board is informed that Rule five (05) of Cantonment Electoral Rules-2007 (CER-2007) provides for reservation of seats for Scheduled Caste (SC) and Scheduled Tribes (ST) in every Cantonment on the basis of the percentage which their population bears to the total population of the Cantonment according to latest Census and the minimum percentage required for such reservation is specified in the First Schedule of the CER-2007.

The number of seat or Seats reserved for the Scheduled Caste or the Scheduled Tribes referred to in sub-rule (1) Rules of CER-2007 shall be allotted to those ward or wards, which have the highest population of Scheduled Castes or Scheduled Tribes, as the case may be and shall be notified by the Central Govt. in the Official Gazette and shall be effective for complete five years or till the next ordinary election, whichever is later irrespective of election to fill any casual vacancy.

In this regard, Draft notification duly passing a Board resolution for ward(s) to be reserved for SC or ST through the Directorate for notification by the Central Government should be forwarded to the DGDE Delhi Cant latest by 10.12.2019.

In this regard, detail of total population of Scheduled Caste and Scheduled Tribes in Jalandhar Cantonment as per Census -2011, is as under ;



In this regard DGDE letter is referred along-with Cantonment Electoral Rules-2007 and all relevant documents are placed on the table for perusal of the Board.

RESOLUTION: The Board perused at length and noted the total population of Scheduled Caste and Scheduled Tribes as 9409 which is approx 20% of the total population figure i.e 47845 of Census-2011 in respect of Jalandhar Cantonment.

Therefore the Board unanimously resolved to reserve **Ward No. VI (Six)**, which is having highest number of population of Scheduled Caste, for Scheduled Caste (SC) as stipulated under Rule 5(2) of Cantonment Electoral Rules-2007 (CER-2007).

Board further resolved to forward the Proposal complete in all respect to the Dte. DE Western Command Chandigarh for onward submission to the Dte. General DE Delhi Cantt for notification of Ward No.VI (Six) of Jalandhar Cantonment, to be reserved for Scheduled Caste(SC) by the Central Government for publication in the Official Gazette.
